landed property to son John for three years, then it is to be sold with the proceeds divided, with sons Daniel, Hugh, James and Samuel each getting \$200 and son John any residue to son John waggon, farm utensils, crosscut saw, mare, 10 head of cattle, 15 sheep, 17 hogs, 1 bed and furniture, and half of the household and kitchen furniture

to his wife and daughters Nancy Carpenter, Jane Benson, Abigail Galford and Mary Beveridge equally debts owed him

to Rebecca Corbit "for long and faithful service to me and my wife" \$50 from John's share of the estate, saddle and bridle, cow and yearling, 6 sheep, bed and furniture

to daughter Peggy Carpenter \$75 loaned son Daniel for her and her husband's benefit
